Brittany entered the program as a college sophomore. She was able to move into our building immediately. "My apartment became my own little safe haven, and I fell in love with my independence."

She credits the weekly therapeutic sessions offered by Pathways as the most valuable component of our program. "Today I love myself more than I ever thought possible.

Not only have I been able to put past hurts to rest, I've also been able to forgive myself for the things that weren't my burden to carry in the first place."

To illustrate her commitment to making our world a more beautiful place, Brittany cites this quote from Jane Goodall: "What you do makes a difference, and you have to decide what kind of difference you want to make."

One way Brittany has been making a difference is through community outreach. Even as a busy full time student, working a part time job, she managed to share her time with orphaned children in Tijuana. She continues her involvement there, at Corazon de Vida, enriching kids' lives through sports, crafts, and music. Her generous and giving spirit, coupled with a love of new places, will provide her with many opportunities to continue to be a force for good in our world.

Brittany graduated just last May from Cal State LA, majoring in Social Work. Nominated by her professors, she was honored with the Leadership Award from the National Society of Leadership and Success. Her long-awaited diploma was the springboard to a future of successful endeavors.

# Charitable Giving & Taxes

**KNOW THE RULES** 

As the new year approaches we hope that you will consider Pathways to Independence in your giving plans and contribute to transforming the lives of the young women we serve.

The greatest benefit of charitable giving is the knowledge that you've helped make a difference in the lives of others. Yet giving can also provide tax breaks so long as you are aware of the rules and keep track of what you have donated. You should always consult with a legal and tax professional on charitable giving matters.

There are several methods of donating to the charities that you support. There are the obvious direct gifts of cash or non-cash gifts of property (including such items as clothing, jewelry, furniture, computers, automobiles and boats) and some not so obvious ways that you can contribute:

are considering current year charitable contributions and are also facing long-term capital gains taxes on appreciated stock they have held for more than a year can realize a much more favorable income tax result and charitable impact by making a timely donation of the appreciated stock directly to Pathways to Independence. If a donor sells the stock first and then donates the cash proceeds to Pathways, the donor may be subject to capital gains taxes on the proceeds from the sale of the stock. But if a donor contributes appreciated stock held for more than one year directly to Pathways, the donor can usually deduct the fair market value of the donation without realizing any capital gain.

**DONOR-ADVISED FUND**- A donor-advised fund is like a charitable investment account and is similar to a family foundation without a lot of the IRS annual regulations.

When you contribute cash, securities or other assets to a donor-advised fund at a public charity, you are generally eligible to take an immediate tax deduction. Then those funds can be invested for tax-free growth, and you can recommend grants to non-profits you care deeply about over time. Consult your tax advisor. Pat hways does not provide tax advice.

**CHARITABLE REMAINDER TRUST (CRT)**- An arrangement in which cash or property is transferred to a trust. You and/or other beneficiaries receive income from the trust for a period of time, after which the remaining principal becomes the property of the charity.

**CHARITABLE LEAD TRUST (CLT)**- A CLT is the opposite. Charities become the income beneficiaries, receiving a stream of income from the trust for a period of time, after which the named noncharitable beneficiaries receive the remaining trust principal.

QCD is a direct transfer of funds from your IRA, payable directly to a qualified charity. Amounts distributed as a QCD can be counted toward satisfying your RMD (required minimum distribution) for the year, up to \$100,000. The QCD is excluded from your taxable income.

Charitable donations are an excellent way to make a difference in the lives of others while also reducing your taxes.
